The undersigned hereby forms and organizes a professional limited liability company pursuant to the Kentucky Limited Liability Company Act and adopts the following Articles of Organization of such professional limited liability company:

ARTICLE I

The name of the professional limited liability company is **JENNIFER CAUDILL BUNDY, ATTORNEY AT LAW, PLLC**.

ARTICLE II

The limited liability company shall have at least one (1) member.

The professional limited liability company shall indemnify, defend and hold harmless its member(s) of and from all debts, obligations and liabilities of the professional limited liability company to the fullest extent of its assets and any insurance the professional limited liability company may possess, as permitted by law.


