### **ARTICLE IX.** Bylaws

The bylaws of the Corporation shall be adopted, and may be amended or repealed by the board of directors as provided in the bylaws.

### **ARTICLE X.** Indemnification

A director of the Corporation will not be personally liable to the Corporation for monetary damages for breach of its fiduciary duties as a director to the extent provided in KRS 273.248, now in effect or hereinafter amended. Any repeal or modification of this Article will not adversely affect any protection of a director with respect to any act or omission occurring before such repeal or modification.

#### **ARTICLE XI.** Limitations on Activities

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (b) by corporation contributions which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section favor for any future federal tax code.

# **ARTICLE XII.** Dissolution

Upon the dissolution of the corporation, assets shall be distributed exclusively for the purposes of the Corporation as set forth in Article II, or for any other exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a federal, state or local government, for a public purpose, as the board of directors shall determine. Any such assets not so disposed of shall be disposed of by the appropriate Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

# **ARTICLE XIII. VETERAN OWNED**
