

**ARTICLES OF ORGANIZATION OF
VEGETABLE MAN PRODUCE, LLC**

KIRK JONES, as ORGANIZER, desiring to form a limited liability company under Chapter 275 of the Kentucky Revised Statutes, hereby states as follows:

ARTICLE I

NAME. The company name is VEGETABLE MAN PRODUCE, LLC (hereinafter referred to as the "Company").

ARTICLE II

DURATION. The duration of the Company shall be perpetual.

ARTICLE III

ARTICLE IV
