Articles of Dissolution

NPD

Pursuant to the provisions of KRS 14A and KRS 273.313, the undersigned corporation executes the following articles of dissolution:

Article I: The name of the nonprofit corporation is

UNITED SOCIETIES OF CHINA STUDIES, INCORPORATED

Article II: The date the dissolution was authorized: **Friday, August 9, 2024**

Article III: This dissolution was approved by **the board of directors**.

Article IV: Meeting date of the Board of Directors at which the resolution was adopted: **Friday, April 19, 2024**

The resolution received the votes of a majority of the directors in office.

Article V: The assets of the corporation shall be distributed pursuant to the following plan of distribution:

- (a) All liabilities and obligations of the corporation shall be paid and discharged, or adequate provisions shall be made therefor;
- (b) Assets held by the corporation upon condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements;
- (c) Assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational or similar purposes, but not held upon a condition requiring return, transfer or conveyance by reason of the dissolution, shall be transferred or conveyed to **USCS has no assets. It has no liability. The United Societies of China Studies (USCS) President Guo Qingli from Ohio State University, Secretary General Jieli Li from Ohio University, Qiang Fang, Vice Secretary General from University of Minnesota, Shiping Hua Council Member and Website Maintainer from the University of Louisville decided to dissolve USCS on October 25, 2023. President Guoqingli who has been responsible to renew the annual registration in recent years sent a note to the Secretary of State of the Commonwealth of Kentucky on April 19, 2024 to dissolve USCS. Shiping Hua, who who registered USCS is now filing this formal report to dissolve USCS. ;**
- (d) Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent that the articles of incorporation or bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others;
- (e) Any remaining assets may be distributed to **No assets. .**

Article VI: This filing will be effective on **Friday, August 9, 2024**.
