The Articles of Incorporation of Chad Lamb Ministries, Inc. are as follows:

ARTICLE I. Name and Duration of Corporation

The name of the Corporation is Chad Lamb Ministries, Inc. ("CLM"). The duration of CLM is perpetual.

ARTICLE II. Purposes of the Corporation

The purpose of CLM is to spread the Gospel of Jesus Christ through conferences, evangelistic and mission endeavors, and any other lawful purpose. CLM is organized exclusively for religious purposes. Therefore, no part of the net receipts of or donations to the corporation shall inure to the benefit of or be distributable to its directors, members, trustees, officers, or other private persons except as authorized in furtherance of its religious purposes.

ARTICLE III. Operation and Governance of CLM

CLM shall be governed by the Board of Directors.

ARTICLE IV. Composition, Authority and Responsibilities of the Board of Directors

Section 1. Composition of the Board of Directors. The Board of Directors of CLM shall be self-perpetuating.

<u>Section 2. Number of Directors.</u> The number of Directors shall be as determined by the Board of Directors in its discretion; provided, however, the number of Directors shall be no less than three (3).

Section 3. Responsibilities of the Board of Directors. The Board of Directors shall have the responsibility and authority set forth in KRS Chapter 273.

Section 4. Term of Service of Directors. Directors shall serve a term of no more than three (3) years, as determined by the Board of Directors at the time of appointment. Directors may serve an unlimited number of consecutive terms but must be reappointed at the end of their terms.
