

ARTICLES OF ORGANIZATION

of

PATTON LAND HOLDINGS, LLC

A KENTUCKY

LIMITED LIABILITY COMPANY

The undersigned, John C. Miller, executes these Articles of Organization for the purpose of forming and does hereby form a limited liability company under the laws of the Commonwealth of Kentucky in accordance with the following provisions.

ARTICLE 1

Name

The name of the limited liability company is "PATTON LAND HOLDINGS, LLC".

ARTICLE 2

Purposes and Powers

The limited liability company shall have any lawful purpose and all the powers conferred upon a limited liability company organized under the provisions of Chapter 275 of the Kentucky Revised Statutes and shall have all powers necessary, proper, convenient or desirable in order to fulfill and further the purposes of the limited liability company.

ARTICLE 3

Initial Principal Office

The mailing address of the initial principal office of the limited liability company in the Commonwealth of Kentucky is 11 Hunter Road, Taylorsville, Kentucky 40071.

ARTICLE 4
Initial Registered Office and Agent

ARTICLE 5
Management

The affairs of the limited liability company are to be managed by manager or managers, subject to the provisions of its operating agreement.

ARTICLE 6
Duration

The limited liability company's existence shall be perpetual.

ARTICLE 7
Other Provisions

Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the limited liability company shall be personally liable for the debts, obligations, or liabilities for the limited liability company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the limited liability company.




