AMENDMENT OF ARTICLES OF INCORPORAT IGLESIA DE DIOS REMANENTE FIEL INC.

We, the directors of the Board of Directors of IGLESIA DE DIOS REMANENTE FIEL INC., a nonprofit religious corporation duly incorporated under the laws of the Commonwealth of Kentucky, met on 09/16/2024 in a duly called meeting. During this meeting, after thorough deliberation and consideration of the needs and purposes of the church, all directors unanimously and by vote resolved to adopt on the same date 09/16/2024 the following amendments and additions to the Articles of Incorporation of the church. These amendments are necessary to comply with the requirements of the Internal Revenue Service (IRS) and to obtain tax exemption under Section 501(c)(3).

AMENDMENTS AND ADDITIONS

The following Articles are hereby added to the Articles of Incorporation:

ARTICLE 1 EXEMPT PURPOSE

Iglesia Cristiana Un Llamado a la Santidad Inc is organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

ARTICLE 2 RESTRICTED ACTIVITIES

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE 3 NO PRIVATE INUREMENT

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Articles of Incorporation.

ARTICLE 4 DISSOLUTION

Upon the dissolution of Iglesia Cristiana Un Llamado a la Santidad Inc, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

APPROVAL AND AUTHORIZATION

It is hereby certified that the directors of the Board of Directors of **IGLESIA DE DIOS REMANENTE FIEL INC.** met on 09/16/2024 and unanimously approved the addition of the aforementioned clauses to the Articles of Incorporation. Furthermore, the President Pastor, **Elder Solis Aguilar**, is authorized to take the necessary steps with the Kentucky Secretary of State to formalize these amendments.
