

# ARTICLES OF ORGANIZATION OF LEGENDS PROPERTIES, LLC

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily formed a limited liability company pursuant to the Kentucky Limited Liability Company Act, KRS Chapter 275, as follows:

## ARTICLE ONE

The name of the limited liability company is LEGENDS PROPERTIES, LLC.

## ARTICLE TWO

## ARTICLE THREE

## ARTICLE SIX


