**ARTICLES OF ORGANIZATION
OF
KING'S LANDSCAPING, LLC**

The undersigned, Glynden Wilson King, hereby executes these Articles of Organization for the purpose of forming, and by the execution of these Articles, does hereby form a limited liability company under the provisions of the Kentucky Limited Liability Company Act and in accordance with the following provisions:

ARTICLE I

The name of the Limited Liability Company is **KING'S LANDSCAPING, LLC**.

ARTICLE II

ARTICLE III




