## ARTICLES OF ORGANIZATION OF COMMUNITY COMPASSION MINISTRIES LLC

The undersigned organizer executes these articles of incorporation for the purpose of forming and do hereby form a nonprofit LLC under the laws of the Commonwealth of Kentucky, KRS 273.161 et seq., in accordance with the following:

### ARTICLE I Name

The name of the corporation is **Community Compassion Ministries L.L.C.**

### ARTICLE II Purpose and Powers

- (A) The LLC is organized and operated exclusively for charitable religious purposes. To carry out its purposes, the organization shall have all the powers allowed organizations by Chapter 273 of the Kentucky Revised Statutes.
- (B) In furtherance of the general purposes in paragraph (A), the particular purposes of the LLC are charitable religious activities included but not limited to fulfilling the great commission of Jesus Christ and providing humanitarian aid the under-privileged in local communities within the United States.
- (C) The purpose for which the organization is organized are exclusively religious, charitable, literary, and educational with the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future of any future United States Internal Revenue Code Law.
- (D) Notwithstanding any other provision of these articles, this organization shall not carry out any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of United States Internal Revenue Code Law.
- (E) In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections of any prior or future in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.
