



**ARTICLES OF ORGANIZATION OF

The undersigned does hereby form and organize a limited liability company pursuant to Chapter 275 of the Kentucky Revised Statutes and Chapter 14 of the Kentucky Revised Statutes, and adopts the following Articles of Organization of such limited liability company:

ARTICLE I: ORGANIZATION

The Company shall be formed as a Limited Liability Company under the laws of the Commonwealth of Kentucky.

ARTICLE II: NAME

The name of the Limited Liability Company shall be, “**Robert T. Parks Insurance LLC**” hereinafter referred to as “Company.”

ARTICLE III: REGISTERED AGENT AND REGISTERED OFFICE

The Company’s registered agent is Robert Taylor Parks. The street address of the Company’s registered office is 2429 Bush Ridge Drive, Suite 101, Louisville, KY 40245.

ARTICLE IV: PRINCIPAL OFFICE

ARTICLE V: COMPANY EXISTENCE

The Company shall be effective upon filing of the Articles of Organization with the Kentucky Secretary of State and shall be perpetual, until its dissolution in accordance with the Company’s operating agreement and the Kentucky Limited Liability Company Act.

ARTICLE VI: MEMBER

The Company’s sole member is, and shall remain, Robert Taylor Parks.

ARTICLE VII: MANAGEMENT

The management of the Company is vested in its Member in accordance with the operating agreement of the Company. The authority of the Member shall be exercised in accordance with the Company's operating agreement.

ARTICLE VIII: PURPOSE

The purpose of the Company shall be limited to transacting insurance business only and this Corporation shall be permitted and allowed to transact any and all lawful insurance business. The Company shall have all powers necessary, proper, convenient, or desire to fulfill and further the purposes of the Company.

ARTICLE IX: ORGANIZERS

Robert Taylor Parks is the Company's Organizer.

ARTICLE X: LIABILITY

Except as otherwise provided by Kentucky law, no member, manager, agent, or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise from the acts or omissions of any other member, manager, agent, or employee of the Company.
