

ARTICLES OF INCORPORATION
Non-profit Corporation

Pursuant to KRS 14A and KRS 273, the undersigned applies to qualify and for that purpose submits the following statements:

Article I: The name of the corporation is The Flight Center.

Article II: The purpose for which the corporation is organized is to provide aviation and engineering workshops to the general public.

Article III: The name of the registered agent is Ryan Sniegowski,

and the street address of the corporation's initial registered office in Kentucky is:

2917 Arlington Court, Louisville, KY 40299.

Article IV: The mailing address of the corporation's principal office is:

Article V: The number of directors (minimum of three required) constituting the initial board of directors is three (3).

Article VII: The application will be effective upon filing.

Article VIII:

- a) This corporation is organized and operated exclusively for educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code.
- b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code, or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code.
- c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

Article IX:

- a) The property of this corporation is irrevocably dedicated to educational purposes, and no part of the net income or assets of the corporation shall ever inure to the benefit of any Director, officer or member thereof, or to the benefit of any private person.
- b) On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes or educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code.
