ARTICLES OF ORGANIZATION  
OF

The mailing address of the initial principal office of the Company shall be located at 644 Phillips Lane, Louisville, Kentucky 40209.



**Article VI**

**Article VII**


The management of the limited liability company is reserved to the members, to be exercised in accordance with the operating agreement of the limited liability company.


