ARTICLES OF ORGANIZATION

OF

SHOT CONTROL SYSTEMS, LLC

The undersigned, serving as the organizer, pursuant to KRS Chapter 275, hereby executes the following Articles of Organization on February 28, 2023, for the purpose of forming a Kentucky limited liability company under the Kentucky Limited Liability Company Act.

ARTICLE I

NAME

The name of the limited liability company shall be Shot Control Systems, LLC (the "Company").

ARTICLE II

CONVERSION; FORMER NAME

The Company is the result of the conversion of Shot Control Systems, Inc., a Kentucky corporation (the "Corporation"), into a limited liability company pursuant to KRS § 271B.12-030 and KRS § 275.376. The former name of the Company was Shot Control Systems, Inc.

ARTICLE III

APPROVAL OF CONVERSION

The conversion of the Corporation into the Company pursuant to KRS § 271B.12-030 and KRS § 275.376 required shareholder approval, which approval was obtained from the sole shareholder of the Corporation by written consent in lieu of a meeting on February 28, 2023. The designation, number of outstanding shares, number of votes entitled to be cast by each voting group entitled to vote separately on the plan of conversion of the Corporation, and number of votes of each voting group indisputably represented by written consent, were as follows:
