ARTICLES OF INCORPORATION OF

J & A Consulting Services, Inc

The undersigned, acting as incorporator of the Corporation under the Kentucky Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be J & A Consulting Services, Inc

ARTICLE II

The existence of this Corporation shall commence upon the issuance of the Certificate of Incorporation, and its duration shall be perpetual, unless sooner dissolved by action of its shareholders in accordance with the laws of Kentucky.

ARTICLE III

The purpose for which the Corporation is formed is the transaction of any and all lawful business for which corporations may be incorporated under Chapter 271B of the Kentucky Revised Statues, and to exercise any and all powers that corporations may now or hereafter be entitled to exercise under the Kentucky Business Corporation Act.

ARTICLE IV

The aggregate number of shares of capital stock which the corporation shall have authority to issue is One Thousand (1,000) shares of Common Stock, all of which are to be without par value. All shares of common stock shall have full and unlimited voting power, and each share shall be entitled to one (1) vote.

ARTICLE V

The liability of each and all of the officers of this Corporation shall be and is hereby limited to the greatest extent permitted by law, and no officer of the Corporation shall be liable to the Corporation or its shareholders for monetary damages for breach of such officer's duties as an continued

officer, except for the following (which exceptions shall be construed as narrowly as legally permissible)

(1) for any transaction in which the officer's personal financial interest is in conflict

with the financial interest of the Corporation or its shareholders;

(2) for acts or omissions not in good faith, or which involve intentional misconduct or are known to the officer to be in violation of law;

(3) for any vote for or assent to an unlawful distribution to shareholders as prohibited under KRS 271B.8 - 330; or

(4) for any transaction from which the officer derives an improper personal benefit.

ARTICLE VI

The address of the initial registered office of the Corporation shall be 4024 Moon Coin Way Lexington, KY 40515 and the name of the initial registered agent at that address shall be Robert Jones.

ARTICLE VII

The name and residence address of the sole incorporator and 60% shareholder of the Corporation is Robert Jones 4024 Moon Coin Way Lexington, KY 40515

ARTICLE VIII

ARTICLE IX

The shareholders of the Corporation shall have preemptive rights regarding all stock issued by the Corporation.

Any written consent by any shareholder, with respect to any action to be taken by unanimous written consent, rather than at a meeting of shareholders, may be signed on behalf of that shareholder by the person or persons who would be entitled to vote that shareholder's shares with respect to the action, if the action were taken at a meeting of the shareholders.
