#### **Article 6 – Indemnification**

To the fullest extent permitted by Kentucky law, the Company shall indemnify its members, managers, officers, and agents from any liability, loss, or expense in connection with the Company's business.

#### **Article 7 – Authority to Issue Debt and Securities**

The Company shall have the authority to issue promissory notes, bonds, or other debt instruments as necessary for financing operations, subject to applicable laws and regulations.

#### **Article 8 – Collateral and Security Interests**

The Company may secure its obligations by pledging its assets as collateral, establishing security agreements, or entering into trust arrangements as required for financial transactions.

#### **Article 9 – Capital Contributions & Distributions**
