**ARTICLES OF INCORPORATION  
OF

**THE UNDERSIGNED**, as incorporator of RAMSEY QUANTITATIVE SYSTEMS - KY, INC. (the "Corporation"), hereby certifies that these Articles of Incorporation are signed for the purpose of forming a stock, for-profit corporation under the Kentucky Business Corporation Act (the "Act"), Chapter 271B of the Kentucky Revised Statutes.

**ARTICLE I**  
**Name**

**ARTICLE II**  
**Shares**

The Corporation is authorized to issue an aggregate of 2,000 shares of voting common stock without par value, all of which shall be common shares without par value. The common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the corporation upon dissolution.



**Effective Date**


