# ARTICLES OF INCORPORATION OF SAFARI SOLUTIONS, INC.

We, the undersigned incorporators, having capacity to contract and acting as the incorporators of a corporation under the <u>Kentucky Business Corporation Act</u>, adopt the following Articles of Incorporation:

#### **ARTICLE I**

The corporation shall be named and known as Safari Solutions, Inc., by which name it may contract and be contracted with, sue and be sued, and do all things necessary or convenient to effect the purposes for which the corporation is organized.
