- 3. Licensing Rights:** Specify that any usage of the name (if applicable for business or religious purposes) must be licensed through SoulTribe Records LLC or its trustees. This creates a layer of legal protection for its usage.
- 4. Intellectual Property:** Include a statement that recognizes your name as intellectual property under the ownership of SoulTribe Records LLC and the holding of LibertyBridge Capital. Make clear that any unauthorized use or infringement will be legally actionable.
- 5. Asset Protection:** Given that it's part of a trust and owned by the LLC, you can include language about asset protection to ensure that your name cannot be attached to personal liabilities or risks associated with other business entities.
- 6. Dissolution and Succession:** In case of dissolution of any entities involved, include terms about how ownership of your name will be transferred or maintained.
