

**ARTICLES OF ORGANIZATION**

We, the undersigned, intending to form and create a limited liability company under the Kentucky Revised Statutes, do hereby state and certify the following:

**ARTICLE I**

**NAME**

The name of the Limited Liability Company shall be “**Outlier Consulting LLC**”.

**ARTICLE II**

**INITIAL REGISTERED OFFICE**

The Member(s), which number shall be fixed by the Operating Agreement of the Limited Liability Company, shall manage the affairs of the Limited Liability Company.
