**Articles of Dissolution**

**NPD**

Pursuant to the provisions of KRS 14A and KRS 273.313, the undersigned corporation executes the following articles of dissolution:

Article I: The name of the non-profit corporation is **GLENSFORK CHURCH OF GOD NEWS, INC.**

Article II: The date the dissolution was authorized: **4/16/2023**

Article III: This dissolution was approved by **the board of directors.**

Article IV: Meeting date of the Board of Directors at which the resolution was adopted: **4/16/2023**  
The resolution received the votes of a majority of the directors in office.

Article V: The assets of the corporation shall be distributed pursuant to the following plan of distribution:

- (a) All liabilities and obligations of the corporation shall be paid and discharged, or adequate provisions shall be made therefor;
- (b) Assets held by the corporation upon condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements;
- (c) Assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational or similar purposes, but not held upon a condition requiring return, transfer or conveyance by reason of the dissolution, shall be transferred or conveyed to **The corporation was originally filed under the name of Glensfork Church of Good News, Inc. When that corporation attempted to amend its articles, they were instead filed in the Secretary of State's Office under the name of Glensfork Church of God News with a separate Kentucky id number. When the annual statement was filed by the Church of Good News, Inc., it was applied toward the Glensfork Church of God News, Inc. which they did not realize was a separate legal entity. The Church of Good News, Inc. was administratively dissolved, but it has now been reinstated. There are no assets to be distributed for the Glensfork Church of God News, Inc. as no assets were ever acquired in that name.;**
- (d) Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent that the articles of incorporation or bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others;
- (e) Any remaining assets may be distributed to **As set forth above, the corporation never had any assets..**
