The undersigned does hereby propose to form a private corporation

under the laws of the Commonwealth of Kentucky.

ARTICLE I

The corporation hereby proposed to be organized shall be known as

and named Country Cookin of Boyd County Kentucky Inc, by which name it may contract and be

contracted with, sue and be sued, adopt a corporate seal, and conduct its business.

ARTICLE II

The purposes of the corporation shall be to transact any and all lawful business for which corporations may be organized under KRS Chapter 271A; including the business of operating and maintaining, country home cooking restaurant, with catering and delivery of prepared foods ; also including the business of borrowing money, with or without surety, and doing any and all acts, and executing and performing any and all other powers, necessary, proper, incident or convenient to carrying out the purposes above set forth, as fully as any natural person might do.

ARTICLE III

The duration of the corporation shall be perpetual unless sooner dissolved by three-fourths of the capital stock outstanding.

ARTICLE IV

ARTICLE V

The aggregate number of shares of stock which the corporation is authorized to issue shall be two thousand (2,000) shares of common stock, of no par value. Each share shall have equal voting rights.

The initial Board of Directors of the corporation shall consist of not less than one nor more than five persons, and the sole director who is to serve until the first annual meeting of the shareholders of the corporation, or until a successor is elected and qualified is:
