Articles of Dissolution

NPD

Pursuant to the provisions of KRS 14A and KRS 273.313, the undersigned corporation executes the following articles of dissolution:

Article I: The name of the non-profit corporation is **MOORISH SCIENCE TEMPLE 5 OF AMERICA, INC.**

Article II: The date the dissolution was authorized: **4/12/2023**

Article III: This dissolution was approved by **the members.**

- (c) Assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational or similar purposes, but not held upon a condition requiring return, transfer or conveyance by reason of the dissolution, shall be transferred or conveyed to **FGB9 LLC, Msta 5 LLC, Grand Cherokee Nationals of North America, Msta Inc, Eidderf El Neerg Msta inc, FGB9 Inc, FGB9, Temple of America inc. FGB9, Temple Inc. Eidderf El Neerg Nfp, Eidderf El Neerg Temple of America Msta9 Inc, State of Illinois, Inc, Chicago, Il (inc), Msta 6, Msta 7, Msta inc. Moorish Science Temple of America.;**
- (d) Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent that the articles of incorporation or bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others;
- (e) Any remaining assets may be distributed to **Freddie Lee Green Junior, Freddie L Green, Freddie L Green Justice, Eidderf El Neerg Ali, Freddie El Green, Heru A Green, Green Family (Members)..**
