ATTACHMENT TO AMENDED ARTICLES OF ORGANIZATION FOR FBC LITTLE LIGHTS, LLC

1. Treasury Regulation Section 1.501(c)(3)-1(b) Compliance

- a. The Company's purpose is limited to only exempt purposes, which are educational and religious. The Company is not empowered to engage in activities that are not in furtherance of one or more exempt activities, except as an insubstantial part.
- b. The Company's purpose is to provide educational services within a Christian context to children of various ages.
- c. The Company shall provide daycare services to children who are not of school age, while providing those children with educational services to help them be better prepared for elementary education. The Company shall further provide after school care for children attending elementary school, while supplementing their primary education. Finally, the Company shall serve as a ministry, teaching Biblical truths.
- d. Upon dissolution of the Company, all assets will be distributed or transferred to First Baptist Church of Hodgenville, Kentucky, Incorporated, which is the sole Member of the Company at present. The Company is presently located at First Baptist Church of Hodgenville, Kentucky, Incorporated's premises.

2. Not a Private Foundation

a. The Company is not a private foundation under Section 509(a)(2)&(3) of the IRC.

3. Requirement that Member(s) be non for profit and tax exempt

a. Any and all Member(s) of FBC Little Lights, LLC shall be an organization described in Section 501(c)(3) of the Internal Revenue Code, and also be exempt from taxation under Section 501(a) of the Internal Revenue Code.

4. Contingency Plan.

a. The Company's present sole member is a 501(c)(3) organization. Should the member cease to be a 501(c)(3) organization, the Company shall be sold to another 501(c)(3) organization with similar goals and objectives.
