The following are Articles of Incorporation of The Fred T. Stoner, Sr. Community Foundation, Inc.:

ARTICLE I:

The name of the corporation is THE FRED T. STONER, SR. COMMUNITY FOUNDATION, INC.

ARTICLE II:

The purpose for which the corporation is organized is to provide educational, advocacy and services to an identified population. Said organization is organized exclusively for charitable, religious, educational and scientific purposes and shall at all times be operated in such a manner as to qualify as an organization exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code of 1986.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or private persons, except that the organization shall be authorized and empowerment to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding and other
