ARTICLES OF INCORPORATION HILLVIEW BOXES OF LOVE, INC.

Pursuant to Kentucky Revised Statutes chapters 14A and 273, the undersigned hereby form a non-profit corporation and for that purpose sets forth the following articles:

ARTICLE I - NAME

The name of the Corporation is Hillview Boxes of Love, Inc.

ARTICLE II - PURPOSE

This corporation is organized exclusively for charitable purposes, including the making of distributions to organizations that qualify as tax-exempt organizations under Section 501(c)(3) of the United States Internal Revenue Code.

ARTICLE III - REGISTERED AGENT

ARTICLE V - BOARD OF DIRECTORS

The business of the corporation shall be conducted by a Board of Directors which shall initially consist of three (3) members until and unless amended in the corporation's bylaws. The members of the Board of Directors shall be appointed as provided in the corporation's bylaws.

ARTICLE VIII - BOARD OF DIRECTORS NOT LIABLE

The private property of the incorporator, the members of the Board of Directors, or any employees or contractors of the corporation shall not be liable for the payment of debts of the corporation.

ARTICLE IX - INCORPORATOR

The incorporator of the corporation is the <u>City of Hillview</u>, <u>Kentucky</u>, a municipal corporation, whose principal office is 283 Crestwood Lane, Louisville, Kentucky 40229.
