

Articles of Incorporation  
Chalice Christian Church, Incorporated

The undersigned, James Connor, being of legal age and acting as the incorporator pursuant to the Kentucky Nonprofit Corporation Acts, adopts the following Articles of Incorporation.

Article I

The name of the corporation is: Chalice Christian Church, Inc.

Article II

The period of duration will be perpetual.

Article III

The object of this nonprofit corporation will be to maintain a church in London, Kentucky affiliated with the Christian Churches (Disciples of Christ) for the religious and charitable purpose of proclaiming the Gospel of Jesus Christ through all areas of its life and work, witnessing in all situations to the grace of God in Jesus Christ; thereby seeking in all persons a response in faith and commitment to Him;

Working cooperatively with other Christians in carrying out the mission of the Church and in making a united witness for Jesus Christ; and

Working for the unity of all Christians and with them engage in the common tasks of building the Kingdom of God.

Article IV

The members at a meeting of members will have power to make bylaws consistent with these Articles of Incorporation and the laws of the Commonwealth of Kentucky.

Article V
