Based upon the Department of Revenue records and the information submitted, **THE FEDERATION OF LUTHERAN CHURCHES (MISSOURI SYNOD) OF LOUISVILLE, KENTUCKY AND VICINITY** is exempt from filing a Kentucky Corporation Income Tax Return pursuant to KRS 141.040, KRS 141.0401 and KRS 136.070.
