STATEMENT OF CHANGE OF PRINCIPAL OFFICE ADDRESS**

**NAME**

Use the exact name of the business entity as registered on file with the Office of the Secretary of State.

**PRINCIPAL OFFICE ADDRESS**

The principal office is the office (in or out of this state) so designated in writing with the Office of the Secretary of State where the principal designated office of the business entity is located. **DOCUMENT DELIVERY**
