

ARTICLES OF INCORPORATION

- The name of this Corporation shall be Airport Bowling Lanes, Incorporated.
- Its purpose shall be to organize, promote, maintain and operate 2. a business establishment for bowlers, including the operation of restaurant and allied businesses, and to do any and all things necessary and proper in the advancement of the sport of bowling.
- Its duration shall be perpetual. 3.
- Its address shall be RFD #4, Elizabethtown, Kentucky. 4. Resident agent shall be B. L. Taylor, c/o Dix-E-Town Lanes, RFD #4, Elizabethtown, Kentucky.
- The authorized capital stock shall be 100 shares of stock; O. each share shall have a par value of \$100.00.
- Any shareholder who at any time wishes to sell his share of stock in this Corporation shall first give each remaining shareholder an opportunity to purchase his shares in equal amounts to the remaining shareholders.
- Upon the death of any shareholder, the sarviving shareholders shall have an option to purchase, running for 90 days after the qualification of his administrator or executor, in equal amounts, all of the shares of stock of the Corporation owned by the decedent.
