The undersigned, desiring to convert an existing corporation to a limited liability company pursuant to Chapter 275 of the Kentucky Revised Statutes, the Kentucky Limited Liability Company Act (the "Act"), hereby certifies as follows:

- 1. <u>Name of Limited Liability Company</u>: The name of the limited liability company is Al Torstrick Insurance Agency, LLC (hereinafter referred to as the "Company").
- 2. <u>Registered Agent and Office</u>: The registered agent and the address of the registered agent's office are as follows:

- 4. <u>Management</u>: The limited liability company is to be managed by its members, subject to provisions of its Operating Agreement, if so enacted by the limited liability company.
- 5. <u>Duration</u>: The duration of the Company shall be perpetual, save and until its dissolution in accordance with the Act and the Operating Agreement of the Company.
- 6. <u>Membership Interest Bound by Terms of Operating Agreement</u>: All members and assignees of membership interests are bound by the terms of the Company's Operating Agreement. The Company's Operating Agreement sets forth certain restrictions on the right of members and assignees of membership interests to assign membership interests.
- 7. <u>Restrictions on Assignment</u>: Pursuant to KRS 275.255(4), as amended from time to time, the Company's Operating Agreement sets forth restrictions on the rights of holders of the Company's membership interests to pledge or assign such interests to creditors. Any pledge or assignment of a membership interest in violation of such restrictions is null and void from the beginning of its existence.
- 8. <u>Limited Liability</u>: No member, manager, employee or agent of the limited liability company shall be personally liable by reason of being a member, manager, employee or agent of the limited liability company, under a judgment, decree or order of a court, agency or tribunal of any type, or in any other manner, in this or any other state, or any other basis, for a debt, obligation or liability of the limited liability company, whether arising in contract, torts or otherwise. The status of a person as a member, manager, employee, or

agent of the limited liability company shall not subject such person to personal liability for the acts or omissions, including any negligence, wrongful act or actionable misconduct of any other member, manager, agent or employee of the limited liability company.

- 9. <u>Statements Made Pursuant to KRS 275.376(11)</u>: The following statements are made pursuant to KRS 275.376(11):
 - a. The limited liability company was previously a corporation and has been converted into a limited liability company.
 - b. The former name of the limited liability company was "Al Torstrick Insurance Agency, Inc."
 - c. There was one class of common stock entitled to vote on the conversion of Al Torstrick Insurance Agency, Inc. from a corporation to a limited liability company. Torstrick OG, Inc. was the owner of One Thousand Sixty-Six (1,166) shares of such common stock, which constituted one hundred percent (100%) of the issued and outstanding shares of common stock in the corporation. One Thousand Sixty-Six (1,166) votes were cast in favor of converting the corporation to a limited liability company, zero (0) were cast in opposition to converting the corporation to a limited liability company, and the number of votes cast in favor of converting the corporation to a limited liability company was sufficient for approval.
- 10. <u>Effective Date</u>: These Articles of Organization shall be effective upon filing.
