ARTICLES OF ORGANIZATION
FOR
REY SALON, LLC
A Kentucky Limited Liability Company

The undersigned, Sean S. Land, hereby executes these Articles of Organization pursuant to Chapter 14A, *et seq.*, of the Kentucky Revised Statutes for the purpose of forming, and hereby does form, a limited liability company under the Kentucky Limited Liability Company Act as enumerated in Chapter 275, *et seq.*, of the Kentucky Revised Statutes, in accordance with the following provisions, to-wit:

ARTICLE I

The affairs of the Company are to be managed by its members subject to the terms and provisions of the Company's written Operating Agreement (as the same, from time to time, may be amended).


ARTICLE VI


