APPENDIX A

THE WOLNITZEK FAMILY FOUNDATION, INC.

Article II: The purpose for which the corporation is organized is to do or perform any and all acts to accomplish charitable, religious, educational and scientific purposes (within the meaning of Section 501(c)(3) of the Internal Revenue Code) in a manner that is permitted under the Internal Revenue Code; Treasury Regulations, rulings or other pronouncements by the Internal Revenue Service or the United States Department of Treasury and KRS § 273.167.

(a) The specific and primary purposes for which this corporation is formed are to operate for the advancement of charity, education, religion and science and for other charitable purposes authorized by KRS § 273.167, by the distribution of its funds for such purposes.

(b) Anything in these articles of incorporation to the contrary notwithstanding, the purpose or purposes for which this corporation is organized are limited to those that will qualify it as an exempt organization under Internal Revenue Code Section 501(c)(3), including for such purposes, the making of distributions to organizations organized and operated exclusively for charitable, religious, scientific or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation. This corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

(d) No part of the net earnings, properties or assets of this corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual or any member, director or officer of this corporation except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article II. On liquidation or dissolution all properties and assets of this corporation remaining after paying or providing for all debts and obligations shall be distributed and paid over to such fund, foundation or corporation organized and operated for charitable, religious, educational or scientific purposes as the board of directors shall determine, and as shall at the time qualify as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code, as such may be amended, or corresponding section of any future federal tax code.
