ARTICLES OF ORGANIZATION

OF

BLUEFIELD INVESTMENTS LLC

KNOW ALL MEN BY THESE PRESENTS:

Pursuant to Chapter 275 of the Kentucky Revised Statutes the undersigned, being 18 years of age or older, states as follows:

1. The name of the **limited liability company** which satisfies the requirements of KRS 275.100 herein organized is **BLUEFIELD INVESTMENTS LLC**.
2. The street address of the limited liability company's initial registered office is **215 North Mulberry Street, Elizabethtown, Kentucky 42701**, and the name of its initial registered agent at that office is **Joshua M. Cooper**.
3. The mailing address of the initial principal office of the limited liability company is **215 North Mulberry Street, Elizabethtown, Kentucky 42701**.
4. The limited liability company has one (1) member. This shall be a member-managed Limited Liability Company.

5. The term of the limited liability company shall be perpetual. {KRS 275.030(2)}



By written signature below the initial registered agent, Joshua Cooper, consents to serve in the capacity as initial registered agent, to receive notice of any legal action, and to give notice to other members of the organization, and further, Joshua Cooper shall see that the Articles of Organization are filed with the Kentucky Secretary of State, that a tax identification number is acquired, and election to do business will be selected and set in place and that an exact or conformed copy of the filing with the Kentucky Secretary of State will be recorded with the County Clerk of Hardin County, Kentucky, where the registered office is situated. {KRS 275.030(5)}


