ARTICLES OF ORGANIZATION
OF

BICKETT AND ASSOCIATES ATTORNEYS AT LAW, PLLC

To the Secretary of State of the Commonwealth of Kentucky:

The undersigned hereby forms and organizes a professional limited liability company in accordance with and pursuant to the Kentucky Liability Company Act and the laws of the Commonwealth of Kentucky, and hereby adopts the following Articles of Organization of such professional limited liability company:

ARTICLE I

The name of the Professional Limited Liability Company is **BICKETT AND ASSOCIATES ATTORNEYS AT LAW, PLLC.**

ARTICLE III

The management of the professional limited liability company is reserved to managers elected and/or appointed in accordance with the operating agreement of the professional limited

liability company. Only those elected or appointed as managers may bind the professional limited liability company, and no member, by reason of being a member, may bind the professional limited liability company. The authority of the managers shall be exercised in accordance with the operating agreement of the professional limited liability company.

ARTICLE IV

The duration of the professional limited liability company shall be perpetual, save and until its dissolution in accordance with the Kentucky limited liability Company Act and the operating agreement of the professional limited liability company. The purpose of the professional limited liability company shall be to practice law, provide legal services and legal counsel which may lawfully be conducted by a professional limited liability company under the Kentucky Liability Act.

ARTICLE V

Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the professional limited liability company shall be personally liable for the debts, obligations or liabilities of the professional limited liability company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the professional limited liability company.


