ARTICLES OF AMENDMENT OF RAFFERTY'S, INC.

16/17/8-9/154.

Pursuant to KRS 271B.10-060, Rafferty's, Inc., Ambientuciping Articles of Amendment:

ARTICLE I

The name of the corporation is Rafferty's, Inc., (the "Corporation").

ARTICLE II

Article IV of the Articles of Incorporation filed with the Kentucky Secretary of State on January 27, 1981, Article II of the Articles of Amendment filed with the Kentucky Secretary of State on March 12, 1991, Article II of the Articles of Amendment filed with the Kentucky Secretary of State on July 5, 1991, and Article II of the Articles of Amendment filed with the Kentucky Secretary of State on December 18, 1992, are hereby amended as follows:

aggregate number of shares which the corporation shall have the authority to issue Million ono Five Hundred (1.500,000) shares of capital stock. shares shall have all the voting power of the corporation, shall be entitled to receive the assets of the corporation dissolution, and shall be without distinction designations, the preferences, limitations or relative rights and priorities.

This amendment was adopted on the 30th day of June, 1994.

All the provisions of the Articles of Incorporation not specifically amended hereinabove shall remain unchanged and in full force and effect.

ARTICLE IV

The amendment of the Articles of Incorporation as set forth above was approved by the unanimous vote of the shareholders. There are three hundred thousand (300,000) shares of common stock authorized, two hundred sixty-one thousand six hundred (261,600) of which are issued and outstanding, each of which was entitled to vote and did vote on the amendment. The total number of votes cast for the amendment was 26,600 (264,600); there were no votes cast against the amendment.
