ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS:

That I, David A. Narramore, of 353 Main Street, Whitesburg, Kentucky 41858, as the incoroporator, pursuant to KRS 273.160 et seq., for the purpose of organizing a non-profit corporation, hereby certify as follows:

ARTICLE I

The Corporation hereby proposed to be organized shall be named COMMUNITY FOUNDATION OF LETCHER COUNTY, INC.

ARTICLE II

The purpose for which the corporation is organized is to raise and distribute funds for donation directly to charitable agencies for the benefit of the citizens of Letcher County, Kentucky, and for such other lawful purposes as provided for in KRS Chapter 273 or as that law may be modified.

ARTICLE III

No part of the income or profit of the corporation shall be distributed to its members, directors, officers, or other private persons, except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of its purposes set forth herein.

In the event of the dissolution of the corporation or winding up of its affairs, or other liquidation of its assests, the corporation shall be conveyed to any organization created or operated for profit, or to any individual for less than the fair market value of

such property, and all assets remaining after the payment of the corporation's debts shall be conveyed or distributed only to an organization or organizations created or operated for non-profit purposes similar to those of this corporation.

ARTICLE IV

The corporation's initial registered office shall be at 95 Main Street, Suite A, Whitesburg, Kentucky 41858, and the name of initial registered agent at that address shall be Angela H. Mullins.
