Williams</u>**, executes these Articles of Incorporation for the purpose of forming and does hereby form a nonstock, nonprofit corporation under the laws of the Commonwealth of Kentucky, KRS 273.161 et seq. , with all the rights privileges and immunities of a corporation organized for religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or it's successor provisions, in accordance with the following provisions.

## ARTICLE I: NAME

### ARTICLE II: PURPOSE

Specifically, this organization is organized for the following purposes:

(i) To support the continuation, maintenance, expansion, and activities of the Greater Destiny Christian Church, Incorporated, and to serve as the primary fund raising organization for Greater Destiny Christian Church, Incorporated.

(ii) To enhance access to capital resources, including a program to encourage philanthropic giving in furtherance of the joint mission of the Corporation and Greater Destiny Christian Church, Incorporated.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
