**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned hereby form and organize a limited liability company pursuant to the Kentucky Limited Liability Company Act, and adopt the following Articles of Organization of such limited liability company:

**ARTICLE I**

The name of the limited liability company is Lafferty Family, LLC.

**ARTICLE III**
