**ARTICLES OF ORGANIZATION  
FOR COMPELLING COLLECTABLES LLC**

The undersigned, a natural person of at least 18 years of age, acting as organizer hereby forms a limited liability company by virtue of KRS 275.020, and adopts the following Articles of Organization for such limited liability company.

**ARTICLE I Name**

The name of the limited liability company is COMPELLING COLLECTABLES, LLC.

**ARTICLE II Principal Place of Business**

The principal place of business of the limited liability company is virtual eCommerce. For the purposes of formation, continuation, and taxation, it shall be construed as operating within the geographic boundaries of the Commonwealth of Kentucky. The principal office address for purposes of documentation shall be 106 Danville Avenue, Stanford, KY 40484.

**ARTICLE III Duration**

This limited liability company shall dissolve and terminate 30 years from the date of the filing of these Articles of Organization with the Secretary of State.

**ARTICLE IV Registered Agent**

The registered agent of this limited liability company in this Commonwealth is the Hon. Seneka S. Land and the business address of the registered agent is 106 Danville Avenue, Stanford, KY 40484.

**ARTICLE V Managers**

The Limited Liability Company shall be managed by its Members.

**ARTICLE VI Purposes**

The purposes for which this limited liability company is formed are to acquire, hold, create, and sell products of a collectable nature, and to engage in any business that a company with limited members may lawfully conduct.

**ARTICLE VII Right to Continue Business**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which may terminate the continued membership of a member ("Dissolution Event") in the limited liability company, the business of the limited liability company may be continued so long as there are at least two remaining members and all members consent to the continuation of business. The managers and/or registered agent of the limited liability company shall call a special meeting of members within ninety (90) days after the Dissolution Event for purposes of determining whether the business should be continued.
