ARTICLES OF ORGANIZATION

of

FORSYTH CONSULTING SERVICES KY, LLC

A KENTUCKY

LIMITED LIABILITY COMPANY

The undersigned, Steve R. Forsyth, executes these Articles of Organization for the purpose of forming and does hereby form a limited liability company under the laws of the Commonwealth of Kentucky in accordance with the following provisions.

ARTICLE 1
