ARTICLE I
NAME

ARTICLE IV
PERIOD OF DURATION

Hawkins Publishing Group, LLC's existence shall begin upon the acceptance of these Articles of Organization by the Secretary of the State of Kentucky for filing in accordance with the Kentucky Limited Liability Act beginning the 1st day of April 2011, and shall continue unless dissolved sooner in accordance with the terms prescribed in **Hawkins Publishing Group, LLC** Operating Agreement, for a period of not less than seventy (70) years.

ARTICLE V MANAGERS


A. The business affairs of **Hawkins Publishing Group, LLC** shall be governed by a Manager in a manner described in the Company's Operating Agreement. The Chief Executive Manager (Owner) shall have all the duties, power, and authority as set forth in **Hawkins Publishing Group, LLC's** Operating Agreement. No other Manager or Members action or any other persons action shall bind **Hawkins Publishing Group, LLC** except as authorized by **Hawkins Publishing Group, LLC's** Operating Agreement.


ARTICLE VI EXCLUSIVE RIGHTS

Hawkins Publishing Group, LLC hereinafter retains exclusivity in matters of intellectual property and is organized to carry on the business as proprietors and publishers of newspapers, journals, magazines, books and other literary works and undertakings; and also to carry on the business as printers, booksellers, bookbinders, paper and stationary makers, engravers, photographers, photographic printers, discography, duplicators, electro-typers, lithographers, machinists, silk screeners, or any other business or manufacture that may seem expedient and / or connected with the publishing business. These rights include but are not limited to copyrights, patents, trademarks, right of publicity, unfair competition, false advertising, fine arts law, and protection of semiconductor chips. It is explicitly stated and seen as an act of overt misrepresentation, theft of product, and/or infringement for any person or persons copying, selling, performing, displaying in digital form or other electronic medium, or making derivative versions of works of authorship produced by this corporation unless written authorization has been expressly granted from **Hawkins Publishing Group, LLC**. Works of authorship can be of any form from all materials produced, written, media, video, internet, or other reproduction such as a translation, adaptation, derivative work, arrangement of music or other alterations of a literary or artistic work, or phonogram or performance and includes cinematographic adaptations or any other form in which the work may be recast, transformed, or adapted including in any form recognizably derived from the original author.

Hawkins Publishing Group, LLC identifies the Chief Executive Manager (Owner) as the original author in the case of a literary or artistic works, as the individual or entity who created the literary work, artistic work or expression as being the producer, or publisher, or legal entity with appropriate ownership of associated rights. Any production in the literary, scientific and artistic domain, whatever may be the mode or form of its expression including digital form, such as a book, pamphlet and other writing; a lecture, address, sermon or other work of the same nature; a dramatic or dramatic-musical work; a choreographic work or entertainment in dumb show; a musical composition with or without words; a cinematographic work to which are assimilated works expressed by a process analogous to cinematography; a work of drawing, painting, architecture, sculpture, engraving or lithography; a photographic work to which are assimilated works expressed by a process analogous to photography; a work of applied art; an illustration, map, plan, sketch or three-dimensional work relative to geography, topography, architecture or science; a performance; a broadcast; a phonogram; a compilation of data to the extent it is protected as a copyrightable work; or a work performed by a variety or circus performer to the extent it is not otherwise considered a literary or artistic work. This right includes the selection, preparation, and distribution of printed matter—including books, newspapers, magazines, pamphlets without limitation and includes publishing of materials in digital formats such as CD-ROMs, as well as materials created or adapted for electronic distribution. Matters pertaining to censorship, plagiarism, royalties for authors, commissions for literary agents, and competitive marketing techniques will be in accordance to provisions stated within **Hawkins Publishing Group, LLC's** Operating Agreement. These rights are not transferable.






