



ARTICLES OF ORGANIZATION
OF
Racer Sign, LLC

The undersigned, serving as organizer, hereby forms a Kentucky limited liability company (the "Company") pursuant to the Kentucky Limited Liability Company Act (the "Act"), KRS Chapter 275, as follows:

1. **Name**: The name of the limited liability company is Racer Sign, LLC.
2. **Initial Registered Office and Agent**: The street address of the Company's initial registered office is 506 Industrial Road, Murray, KY 42071. The name of its initial registered agent at that office is Jonathan Duncan.
3. **Initial Principal Office**: The mailing address of the initial principal office of the Company is 506 Industrial Road, Murray, KY 42071.
4. **Statement of Management**: The limited liability company is to be managed by one or more managers, to be exercised in accordance with the operating agreement of the Company.
5. **Dissolution**: The Company does not have a specific date of dissolution. The Company shall dissolve as provided in the Act and the Company's operating agreement.
6. **Statement of Limited Liability**: Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the Company.

CONSENT OF REGISTERED AGENT


