Our designated Registered Agent (Vivek Sharma) certifies to the fact that he himself has not filed any such Statement of Resignation. This has been a case of Identity Theft wherein an unauthorized person falsely pretending to be our Registered Agent filed such Statement.

3. The inaccuracy or defect stated above should be corrected as follows:

1) The Registered Agent appointed by Kripa Connection International, Inc is VIVEK SHARMA. The address of our Registered Agent is 15204 ABINGTON RIDGE PLACE, LOUISVILLE, KENTUCKY 40245.

2) The afore mentioned fraudulent filing dated 08-30-2023 be removed and the filing record expunged.

3) We are also requesting the Kentucky Secretary of State to implement the levying of an appropriate filing fee for Statement of Resignation of Registered Agent. Such a filing fee will act as a deterrent to unscrupulous persons or entities from fraudulently filing records online at the website of KY Secretary of State.
