ARTICLES OF INCORPORATION

of

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, desiring to form a Professional Service Corporation in accordance with KRS Chapters 274 and 271B, for the practice of dentistry, does hereby certify:

1. The name of the Corporation shall be:

Gwen Bates, P.S.C.

2. The duration of said Corporation shall be perpetual.

3. The purposes for which it is formed are: The transaction of any or all lawful business for which corporations may be incorporated under KRS Chapter 271B, as expanded and modified under the applicable provisions of KRS Chapter 274.

4. The aggregate number of shares which the Corporation shall have the authority to issue shall be One Thousand (1,000); such shares consisting of one class, only; all shares to be No Par Value shares; and further, said shares shall be issued in such a manner as to conform with an IRS Code 1244 Election.

5. Shareholders' preemptive rights shall be consistent with KRS 271B.130.

6. The regulation of internal affairs of the Corporation, including any provision restricting transfer of shares, shall be exclusively governed by the By-Laws of the Corporation.
