Article I  
Name

The name of this non-profit organization is:

Article II  
Purpose

The purpose of this non-profit organization, Eastern High School Football Parents Association, Inc., is to further the physical education of the Eastern High School students who choose to participate in the athletic endeavors sanctioned by the Jefferson County Board of Education and Administration of Eastern High School, with the primary emphasis focused on the Football Program.

Article III

The purpose for which the corporation or association is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 502 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any further United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 502 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any further United States Internal Revenue code.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court or competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.




