ARTICLES OF ORGANIZATION
OF

CHRISTINA STACY, PH.D., PLLC

The undersigned, acting as the organizer, hereby forms a professional limited liability company under the laws of the Commonwealth of Kentucky, namely the Kentucky Business Entity Filing Act, Kentucky Revised Statutes Chapter 14A, and the Kentucky Limited Liability Company Act, Kentucky Revised Statutes Chapter 275 (the latter hereinafter referred to as the "Act").

ARTICLE I

NAME

The name of this professional limited liability company is CHRISTINA STACY, PH.D., PLLC (the "Company").

ARTICLE II

ARTICLE VI


PROFESSION

ARTICLE VII


