

ARTICLES OF ORGANIZATION
OF
CRAFTON AUTO REPAIR, LLC

The undersigned organizers, desiring to form a limited liability company under the Kentucky Limited Liability Company Act (the "ACT"), KRS Chapter 275, hereby state the following:

1. **NAME.** The name of the limited liability company (the "COMPANY") is Crafton Auto Repair, LLC.
2. **TERM.** The existence of the Company will be perpetual, except as provided in the Company's Operating Agreement.
3. **REGISTERED OFFICE AND AGENT.** The street address of the Company's initial registered office shall be 860 Federal Street, Franklin, Simpson County, Kentucky 42134, and the initial registered agent at that office shall be Lessye Marie Crafton.
4. **PRINCIPAL OFFICE.** The mailing address of the initial principal office of the Company shall be 860 Federal Street, Franklin, Simpson County, Kentucky 42134.
5. **PURPOSE.** The purpose for which the Company is formed is to engage in lawful acts or activities for which limited liability companies may be formed under Chapter 275 of the Kentucky Revised Statutes.
6. **MANAGEMENT.** The Company is to be managed by its members. No member, manager, officer, employee, or agent of the limited liability company shall be personally liable by reason of being a member, manager, officer, employee, or agent of the limited liability company, under a judgment, decree, or order of a court, agency or tribunal of any type, or in any manner, in this or any other state, or on any other basis, for a debt, obligation, or liability of the limited liability company, whether arising in contract, tort, or otherwise.

The status of a person as a member, manager, officer, employee, or agent of the limited liability company shall not subject him or her to personal liability for the acts or omissions, including any negligence, wrongful act, or actionable misconduct, of any other member, manager, officer, agent, or employee of the limited liability company.

7. **EFFECTIVE DATE.** This application will be effective upon filing.
