The business entity shall notify the Secretary of State in the future of any change in its mailing address.
6. This application will be effective upon filing.

CERTIFICATE OF WITHDRAWAL OF A FOREIGN BUSINESS ENTITY

NAME

DOCUMENT DELIVERY

If the applicant wishes for the document to be sent to an alternate address other than the principal office, a request must be submitted in writing affirming that request. Alternate address requests must be submitted with each document filed with the Office of the Secretary of State.

WHO MAY SIGN

The document must be signed by an officer, chairman of the board, member, manager, partner or trustee.
