### ARTICLES OF INCORPORATION OF ROY'S REBELS, INC. A KENTUCKY NON-PROFIT CORPORATION

The undersigned organizer hereby executes these Articles of Incorporation for the purpose of forming and does hereby form a non-profit corporation pursuant to KRS 14A and KRS 273 of the Commonwealth of Kentucky in accordance with the following provisions:

### ARTICLE I NAME

The name of the corporation is "Roy's Rebels, Inc."

## ARTICLE II PURPOSE

The organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of the Organization shall inure to the benefit of, or be distributable to its Directors, Officers, or other private persons, except that the Organization shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article II. No substantial part of the Organization's activities shall consist of promoting propaganda or otherwise attempting to influence legislation, and the Organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Bylaws, the Organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

# ARTICLE III INITIAL REGISTERED OFFICE AND REGISTERED AGENT
